




PAROTID LYMPHANGIOMA IN ADULT- A RARE CASE ENTITY




We present a case report of a 42-year-old male with a chief complaint of painful swelling in front of the left ear and gradual reduction in mouth opening since 5 years. Extraoral examination revealed diffuse, firm, tender, non-compressible swelling measuring approximately 3x2 cm in the left pre-auricular region. The maximal interincisal opening was 26 mm. No facial nerve weakness was apparent. FNAC of the preauricular swelling was performed, and it was suggestive of reactive lymphoid hyperplasia. Panoramic radiograph revealed depression in the posterior border of the left ramus suggesting resorptive change. Contrast enhanced MRI of the TMJ revealed well defined lobulatedlesion, measuring approximately 33x32x35 mm appearing heterogeneously hyper intense on T2W/ STIR images and isointense on T1W.It was seen along the posterior aspect of the left mandibular condyle arising predominantly from the deep lobe of the parotid gland with superiorly extending up to the TMJ, posteriorly up to the pre-styloid region and medially abutting the lateral pterygoid muscle.CT angiography of the face and neck revealed terminal part of the left external carotid artery (ECA) entering into the lowermost margin of the tumour and then dividing into the terminal branches within the tumour as internal maxillary and superficial temporal artery. Total parotidectomy was scheduled under general anaesthesia. Modified Blair's incision was given, and the superficial cervicofacial flap was raised up to SMAS. Skeletonization of sternocleidomastoid, posterior belly of digastric, cartilage of external auditory canal up to the tragal pointer and mastoid tip was performed, which aided in the identification of location of the facial nerve. External jugular vein and External carotid artery was identified and ligated. Using blunt dissection, superficial lobe of the parotid gland was dissected from the branches of the facial nerve. Deep lobe of the parotid along with the tumour was separated from the condyle and lateral pterygoid muscle and it was delivered between the splayed branches of the facial nerve. Layer-wise primary closure was achieved and suction drain was placed. Both superficial and deep lobes of the parotid were sent for histopathological examination which revealed normal salivary gland architecture of superficial lobe and cavernous lymphangioma of deep lobe of parotid. The post-operative course remained uneventful except for facial nerve weakness with House-Brackmann score 3 in the immediate post-operative period. The patient was kept on a tapering course of injectable steroids followed by oral steroids for 20 days along with mecobalamin 1500 mcg once daily. His House-Brackmann score improved to 2 in the post-operative 6-month period. Mouth opening improved to 37 mm.



Merging Technology and Technique: Piezoelectric-Assisted Chin Grafting for Implant Site Optimization

A 28 year old male presented to the Department of Oral and Maxillofacial Surgery with the chief complaint of missing maxillary anterior teeth. Clinical and radiographic evaluation, including conebeam computed tomography (CBCT), revealed significant bone deficiency with the absence of the buccal cortical plate at the proposed implant site. To address the defect and facilitate implant placement, a treatment plan was advised for the placement of a conventional implant along with autogenous bone grafting harvested from the chin using piezoelectric surgery, as per the protocol described by Desai et al.

Under local anesthesia, a 1.5 cm autogenous bone graft was harvested from the symphysis region using a piezoelectric surgical unit to ensure precise and atraumatic removal. The harvested graft was contoured and secured at the recipient site using a 8 mm monocortical titanium screw to augment the deficient alveolar ridge with beta tricalcium phosphate of amount 60 mg. An implant was subsequently placed at the site with an insertion torque of 30 Ncm, ensuring primary stability. Primary closure was achieved using 3-0 silk sutures for both the donor site and the implant recipient site. Postoperative evaluation included an orthopantomogram (OPG), which confirmed appropriate graft placement and implant stability.

This case highlights the clinical utility of autogenous symphyseal graft harvested with piezoelectric unit in addressing challenging alveolar ridge deficiencies. The incorporation of precise surgical techniques and the achievement of optimal implant stability contributed to a predictable and successful outcome, demonstrating the effectiveness of this approach in complex oral rehabilitation cases.

Cadaveric Craniofacial Distraction hands-on Course



The Department of Plastic & Reconstructive Surgery at Amrita Hospital conducted its first "Cadaveric Craniofacial Distraction hands-on Course" on November 15 & 16, 2024. The course was led by the Craniofacial team at Amrita Hospital, Faridabad comprising of Dr Anil Murarka (Plastic Surgeon), Dr Arun Sharma (Oral & Maxillofacial Surgeon), Dr Sachin Gupta (Paediatric Neurosurgeon), and Dr Aditi Poddar Sharma (Orthodontist). It was conducted under the joint aegis of Association of Oral & Maxillofacial Surgeons of India - Delhi NCR State Chapter and Association of Plastic Surgery Delhi State Chapter. The course was well supported by KLS Martin, India. The invited faculty were - Dr PramodSubash (Craniofacial unit head, Amrita Hospital, Kochi) and Dr Arjun Krishnadas (Consultant Craniofacial Surgeon, Amrita Hospital, Kochi).

The course saw active participation from 18 surgeons of both specialties - Plastic Surgery and Oral & Maxillofacial Surgery- travelling from all corners of the country and abroad. The first day involved CME-only wherein different distraction appliances were demonstrated and techniques were described through a combination of lectures and videos. The invited faculties and the hosts took turns to deliver lectures on different types of distraction techniques employed in the



craniomaxillofacial region. KLS Martin, India brought a vast range of distractors for exhibition and table discussion. The course faculty described each distractor, its components and applications in detail. There were additional lectures on anesthetic considerations and the role of Paediatric intensivist with the comprehensive management of craniofacial patients. The second day consisted of hands-on training on Synbone models and cadaver. Lefort III ostetomy and application of calvarial and mandibular distractor was performed by participants on either synbone model or cadaver. The course was well received by all participants.











